Richardson reserves the right to reject any order. Any e-mail from Richardson that acknowledges receipt of an Order, shall not be deemed acceptance of the Order. In addition, communications from Richardson by e-mail shall not be deemed to constitute an amendment or modification of any terms and conditions or an electronic signature by Richardson.
